- § Be able to provide evidence of equivalent qualifications or Accreditation by a recognised industry organization AND be able to verify building experience.
- § Possess current Professional Indemnity insurance covering the specific fields of practice/expertise applied for, Certificate of Currency & Policy Schedule is required with Application,
- § Provide documentary evidence of Accreditation, Tertiary Qualifications and/or other verifiable evidence of qualification.
- § Provide evidence of experience as a practicing consultant with a minimum of 5 years appropriate experience deemed to be suitable by the Executive Committee.
